- THAT Clause 2 preamble and subsection a) be amended to read as follows:
 - "2. THAT all persons are prohibited from using any catapult, sling, bow and arrow, pellet gun or any other weapon to discharge any stone, arrow, bullet, pellet, missile or other projectile, on, within, onto, or through any of the following areas or territories located within the boundaries of the municipality of Snow Lake:
 - a) Townsite of Snow Lake, excepting thereout the Joe Bauhs Indoor Range for the authorized use of bows and arrow.

2. THAT this by-law shall come into effect upon third reading.

BY-LAW NUMBER 733/94

BEING A BY-LAW TO PREVENT THE USE OF FIREARMS AND BOWS AND ARROWS IN CERTAIN AREAS.

WHEREAS it is deemed necessary and expedient to prohibit the use of firearms and bows and arrows within certain inhabited areas of the Town of Snow Lake, for protection of the residents of the municipality, pursuant to Section 297 of the Municipal Act.

NOW THEREFORE, Council of the Town of Snow Lake, in Council duly assembled, hereby enacts as follows:

- 1. THAT all persons, except Peace Officers in the lawful execution of their duties and Registered Trap Line holders not designated Junior Trappers, are prohibited from firing and discharging any gun, rifle, revolver, pistol or other firearm on, within, into, onto or through the following areas and territories located within the boundaries of the Town of Snow Lake:
 - a) Townsite of Snow Lake, excepting thereout the Joe Bauhs Indoor Range;
 - b) South End, Lots 1 and 2, Plan 2849, registered in the Portage Land Titles Office;
 - c) Highway 392 from a point one kilometre south of Wekusko Falls Lodge, northerly to a point one kilometre north of Anderson Bay Cabin subdivision as shown on Plan 24309 registered in the Portage Land Titles Office
 - d) Within two kilometres of the area or territory as described in sub-paragraph 1(a);
 - e) Within one kilometre of the areas or territories as described in sub-paragraphs 1 (b) and (c) above.
- 2. THAT all persons are prohibited from using bows and arrows to discharge any arrow or other projectile on, within, into, onto or through any of the following areas or territories within the boundaries of the Town of Snow Lake
 - a) Townsite of Snow Lake, excepting thereout the Joe Bauhs Indoor Range;
 - b) South End, Lots 1 and 2, Plan 2849, registered in the Portage Land Titles Office;
 - c) Highway 392 from a point one kilometre south of Wekusko Falls Lodge, northerly to a point one kilometre north of Anderson Bay Cabin subdivision as shown on Plan 24309 registered in the Portage Land Titles Office
 - d) Within three hundred metres of any of the areas or territories described in sub-paragraphs 2 (a) to (c) at
- 3. Any person who contravenes, disobeys, violates or fails to comply with any provision of Section 1 of this by-law is guilty of an offense and is liable, on summary conviction, to a fine of One Thousand Dollars (\$1,000.00).
- 4. Any person who contravenes, disobeys, violates or fails to comply with any provision of Section 2 of this by-law is guilty of an offense and is liable, on summary conviction, to a fine of not more than One Thousand Dollars (\$1,000.00)
- 5. This by-law shall come into force and effect upon third reading.
